In consideration of the undersigned ("**Participant**") being permitted to operate vehicles and/or otherwise participate in, observe, and/or attend one or more riding, driving, and/or racing schools, events, and/or programs (all such activities collectively referred to herein as "**The Mid-Ohio School**") operated at and/or by Green Savoree Mid-Ohio, LLC d/b/a Mid-Ohio Sports Car Course d/b/a Mid-Ohio School ("**GSMO**"), and/or being permitted to enter for any purpose or in any capacity a "**Restricted Area**" (defined as the area where The Mid-Ohio School will be held and/or to which access is permitted including, without limitation, any track, building, garage, pit, infield, burnout, approach, shut down, and paddock area, and the racing surface, walkways, concessions and other appurtenant areas and surrounding premises), Participant and the Participant's undersigned parents and/or guardians (collectively "**Parent/Guardian**") acknowledges, represents and agrees that Participant and/or Parent/Guardian, on behalf of Participant, Parent/Guardian and their personal representatives, spouse, children, heirs, next-of-kin, and assigns (collectively "**Releasors**"), has read, executed, and understands this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement (the "**Release**") and further represents, warrants, and agrees as follows:

1. Participant and Parent/Guardian hereby acknowledge and agree that any and all activities and/or events associated with and/or occurring at and/or in The Mid-Ohio School, the Restricted Area, the Vehicles (defined in Exhibit A), the Participant Vehicle (defined in Exhibit A) and/or Third Party Vehicles (defined in Exhibit A) are specifically covered by the Release and that all such activities and events are an "**Event**" within the meaning of the Release. This Release is irrevocable and applies to any and all Events which Participant and/or Parent/Guardian attends, observes, and/or participates and to all times and dates Participant and/or Parent/Guardian is in the Restricted Area.
2. Participant and Parent/Guardian acknowledge, agree, and represent that Participant and Parent/Guardian have or will immediately upon entering any Restricted Area, Vehicle, Participant Vehicle, and/or Third Party Vehicle and will continuously thereafter, inspect the Restricted Area, Vehicle, Participant Vehicle and Third Party Vehicle, and further agree, represent, and warrant that if at any time Participant and/or Parent/Guardian is in or about any Restricted Area, Participant Vehicle, Third Party Vehicle, and/or Vehicle and Participant and/or Parent/Guardian believes anything to be unsafe, Parent/Guardian will instruct Participant to and Parent/Guardian and Participant will immediately advise the officials of such and Parent/Guardian will instructed Participant to leave and Participant and Parent/Guardian will leave the Restricted Area, Vehicle, Participant Vehicle and/or Third Party Vehicle, and refuse to participate further in the Event.
3. "**Releasees**" shall mean: (i) all individuals and entities associated with The Mid-Ohio School, Vehicles, Restricted Area, and/or Events, including, without limitation, GSMO, The Mid-Ohio Sports Car Course, and their respective owners, officers, directors, agents, contractors, and employees; (ii) all instructors and independent contractors or other persons either enrolled, teaching, or otherwise participating in The Mid-Ohio School and/or Events; (iii) the promoters, organizers, sponsors, corporate partners, suppliers, participants, racing associations, sanctioning organizations, officials and their assistants, Vehicle owners and drivers, pit crews, mechanics, maintenance personnel, rescue personnel, and on-site medical personnel associated and/or involved with the Restricted Area, The Mid-Ohio School, Event and/or Vehicles; (iv) all designers and constructors of the Restricted Area, The Mid-Ohio School and/or Vehicles; (v) Restricted Area, Vehicle, and Event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the Restricted Area, Vehicles, The Mid-Ohio School, or Event; (vi) all owners, lessees, lessors, manufacturers, mechanics, distributors, wholesalers, retailers, designers, inspectors, and sponsors of all Vehicles and all racing and other equipment used at and/or in the Restricted Area, any Event, and/or The Mid-Ohio School; (vii) all other persons, firms, or companies insured by any liability policy procured by or on behalf of or relating to the Event, Vehicles, Restricted Area, or The Mid-Ohio School; (viii) other Event

participants; and (ix) the parent companies, subsidiaries, affiliates, directors, officers, owners, agents, contractors, and employees of all of the foregoing.

4. Parent/Guardian and Participant, individually and on behalf Parent/Guardian and Participant and all of the Releasors hereby release, waive, discharge, and covenant not to sue the Releasees FROM ALL LIABILITY TO PARTICIPANT, PARENT/GUARDIAN AND/OR ANY OF THE RELEASORS, FOR ANY AND ALL LOSS, DAMAGE, COSTS, EXPENSE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO PARTICIPANT, PARENT/GUARDIAN, AND/OR ANY OF THE OTHER RELEASORS OR THE RELEASOR'S PROPERTY OR RESULTING IN DEATH, INJURY, DISABILITY, OR PARALYSIS OF PARTICIPANT, PARENT/GUARDIAN, AND/OR ANY OF THE RELEASORS ARISING OUT OF OR RELATED TO THE EVENT, THE VEHICLES, THE PARTICIPANT VEHICLE, THIRD PARTY VEHICLES, THE MID-OHIO SCHOOL, AND/OR RESTRICTED AREA, from any cause whatsoever, including, without limitation: (i) the failure of anyone to make and/or enforce rules and regulations; (ii) the failure to make inspections and/or repairs; (iii) the condition and/or design of any portion of the Restricted Area, Vehicles, Participant Vehicle, and/or Third Party Vehicles; (iv) negligent rescue operations and/or procedures; (v) defective products, defective Vehicles, defective Participant Vehicle and/or defective Third Party Vehicles; (vi) lack of insurance and/or insufficient insurance on the Event, Restricted Area, Vehicles, Participant Vehicle, and/or Third Party Vehicles; (vii) damage to and/or destruction of the Vehicles, Participant Vehicle, Third Party Vehicles and/or any other property of Parent/Guardian and/or Participant; and/or (viii) any act or omission of the RELEASEES or any of them or any other act WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE AND WHETHER OR NOT OCCURRING IN A RESTRICTED AREA (COLLECTIVELY "**CLAIMS**").
5. The Participant and Parent/Guardian further understand (and Parent/Guardian has explained to Participant) that serious accidents occasionally occur in the Restricted Area, at Events, while driving Vehicles or the Participant Vehicle or Third Party Vehicles, on a race track, or during Vehicle, Participant Vehicle, or Third Party Vehicle racing, testing, driving, schooling and practice, and that participants in and observers of such activities can sustain mortal or serious personal injuries and/or property damage, as a consequence thereof including, but not limited to, bodily injury, permanent disability, paralysis, and death. The Participant and Parent/Guardian also expressly acknowledge (and Parent/Guardian has explained to Participant) that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES, THE CONDITION AND LAYOUT OF THE PREMISES AND EQUIPMENT, THE RULES OF THE EVENT, THE ACTIONS AND INACTIONS OF OTHERS PARTICIPATING IN THE EVENT, THE PARTICIPANT'S ACTION AND INACTIONS, AND THE NEGLIGENCE, ACTS, AND OMISSIONS OF THE RELEASEES. Knowing the risks of such activities, nevertheless, the Participant and Parent/Guardian HEREBY AGREE ON BEHALF OF PARTICIPANT, PARENT/GUARDIAN AND ALL RELEASORS TO ASSUME FULL AND COMPLETE RESPONSIBILITY FOR, AND TO COMPLETELY RELEASE RELEASEES FOR RISK OF, BODILY INJURY, DEATH, PROPERTY DAMAGE OR ANY OTHER TYPE OR KIND OF INJURY OR DAMAGE WHICH OCCURS TO THE PARTICIPANT, PARENT/GUARDIAN, AND/OR ANY OF THE RELEASORS, INCLUDING, BUT NOT LIMITED TO, WHILE PARTICIPATING IN, PREPARING FOR, WORKING FOR OR ENTERING FOR ANY PURPOSE ANY "RESTRICTED AREA" OR IN ANY OTHER WAY INVOLVING THE EVENT, RESTRICTED AREA, THE VEHICLES, THE PARTICIPANT VEHICLE, THIRD PARTY VEHICLES, AND/OR THE MID-OHIO SCHOOL.
6. Participant and Parent/Guardian, jointly and severally, agree to assume full responsibility for, and agree to indemnify, defend, and hold Releasees harmless from and against any and all Claims, demands, liabilities, litigation, damages, losses, costs and expenses (including, without limitation, reasonable attorneys' fees) arising out of or in connection with: (i) the Restricted Area, Event, The Mid-Ohio School, Vehicles, the Participant Vehicle and/or Third Party Vehicle; (ii) Participant's participation in and/or observation of The Mid-Ohio School and/or the Event; (iii) any breach or alleged breach by Participant, Parent/Guardian, or any Releasor of any provision of this Release; (iv) any act or omission of Participant, Parent/Guardian, and/or any Releasor; (v) any and all Claims brought and/or alleged by the Participant, Parent/Guardian, and/or any of the other Releasors; (vi) any bodily injury, personal injury, death, and/or property damage suffered by Participant, Parent/Guardian and/or any Releasor; (vii) any and all Claims, whether caused by the negligence of the Releasees or otherwise (including, but not limited to, Claims of loss of consortium by any of the Releasors); and/or (viii) actions, Claims and/or demands relating to and/or which are not barred and/or not released as a result of the invalidity, voidability, or enforceability of this Release by reason of Participant being under the age of eighteen (18) at the time of execution.
7. The Participant and Parent/Guardian agree that this Release extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Municipality

and/or State in which the Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This Release shall be construed and interpreted in accordance with the laws of the State of Ohio and all litigation relating to this Release and/or Claims shall be subject to the exclusive jurisdiction of the courts of the state of Ohio and county in which the Restricted Area is located. In the event of any conflict between the Release and any other agreement, statement, and/or documents, this Release shall control. Participant and Parent/Guardian acknowledge that Participant and/or Parent/Guardian may be required to execute other releases, waivers and agreements in relation to The Mid-Ohio School and/or Event and that all such releases and agreements will remain in full force and effect after the execution of this Release and that this Release remains in effect after the execution of such other releases and agreements.

8. Participant and Parent/Guardian agree that there shall be NO TIME LIMIT on the releases, waivers, discharges, covenants not to sue, indemnifications and hold harmless clauses and assumptions of risk taken pursuant to this Release. ALL SAID AGREEMENTS AND REPRESENTATIONS SHALL CONTINUE FROM THIS DATE FOREVER and shall protect the Releasees from exposure in any way, directly or indirectly, resulting from the Event, The Mid-Ohio School, Restricted Area, Vehicles, Participant Vehicle, Claims, and Third-Party Vehicles from and after the date of this document.
9. PARTICIPANT AND PARENT/GUARDIAN HAVE READ THIS RELEASE, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT PARTICIPANT, PARENT/GUARDIAN, AND THE OTHER RELEASORS HAVE GIVEN UP SUBSTANTIAL RIGHTS BY PARTICIPANT AND PARENT/GUARDIAN SIGNING IT, AND PARENT/GUARDIAN AND PARTICIPANT HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO THE PARTICIPANT AND/OR PARENT/GUARDIAN AND INTENDS THE PARTICIPANT'S AND PARENT/GUARDIAN'S SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. PARTICIPANT AND PARENT/GUARDIAN HAVE READ AND VOLUNTARILY SIGN THIS RELEASE AND FURTHER AGREE THAT NO ORAL REPRESENTATIONS, STATEMENTS, OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN RELEASE HAVE BEEN MADE.
10. Participant and Parent/Guardian acknowledge and agree that the execution and delivery of this Release constitute a material inducement and condition to GSMO's permitting Participant and Parent/Guardian to enter the Restricted Area, to use a Vehicle, to use the Participant Vehicle, and participate in The Mid-Ohio School and Event.
11. Participant and Parent/Guardian represent, warrant, and agree that: (i) this Release shall be binding upon and enforceable against Participant, Parent/Guardian, and the other Releasors without limitation; and (ii) that Parent/Guardian has the authority, and the Participant's and other Releasors' consent, to bind Participant and all such persons to the provisions of this Release and to execute this Release on their behalf; and (iii) Parent/Guardian has knowledge of and consents to Participant's participation in and/or observance of the Events and/or The Mid-Ohio School, presence in the Restricted Area, and use of the Vehicles, the Participant Vehicle and/or Third Party Vehicles.
12. The Vehicle Responsibility, Media and Medical Acknowledgment and Agreement Minor is attached hereto as Exhibit A and incorporated herein by reference ("**Exhibit A**").
13. THE PARENT/GUARDIAN SIGNS THIS RELEASE ON THEIR BEHALF AND ON BEHALF OF THE PARTICIPANT AND OTHER RELEASORS. THE PARENT/GUARDIAN CONSENT TO THE PARTICIPANT'S PARTICIPATION IN THE EVENT, ENTRY INTO RESTRICTED AREAS, AND OPERATION AND/OR OCCUPANCY OF VEHICLES, THE PARTICIPANT VEHICLE, AND THIRD PARTY VEHICLES, AND HEREBY ACCEPTS AND ASSUMES ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUMES ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING PARTICIPANT'S INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES.

VEHICLE RESPONSIBILITY, MEDIA AND MEDICAL ACKNOWLEDGEMENT AND AGREEMENT MINOR

1. During certain Events, Participant may be permitted to use a Participant-owned or Parent/Guardian owned and/or supplied vehicle ("**Participant Vehicle**") and The Mid-Ohio School may permit other participants to use vehicles they supply and/or own ("**Third Party Vehicles**"). Participant and Parent/Guardian agree that prior to operation of a Participant Vehicle at The Mid-Ohio School, in any Event and/or in the Restricted Area, Participant and Parent/Guardian shall provide The Mid-Ohio School evidence of the following:

- (a) Participant's or Parent/Guardian's ownership of the Participant Vehicle (such evidence shall include producing title and registration of such Participant Vehicle).
- (b) Financial responsibility in accordance with Ohio law (such proof shall include Participant's and/or Parent/Guardian's current vehicle insurance card).

The Mid-Ohio School's and/or GSMO's failure to obtain this information regarding the Participant Vehicle or any Third-Party Vehicle shall not subject the Releasees to any liability and/or claims of the Releasors. Participant and Parent/Guardian agree that the Releasees shall in no way be responsible for damage to the Participant Vehicle, or for any passengers or instructors (collectively "**Passenger**") who ride in the Participant's Vehicle or any Third-Party Vehicles at The Mid-Ohio School and/or any Event. This is completely and solely at the liability and risk of the Participant, Parent/Guardian, and Passenger. The Participant and Parent/Guardian, jointly and severally, indemnify, defend, and hold harmless the Releasees from and against any and all forms of damage, harm, expense (including attorney fees), liability and Claims as a result of this activity and/or the Participant Vehicle.

2. Participant and Parent/Guardian acknowledge and agree that, although Releasees may refer Participant and/or Parent/Guardian to companies or persons who sell, lease or rent vehicles and/or although Releasees may provide, sell, lease, or rent vehicles (including, but not limited to, cars, motorcycles and ATVs) for use at The Mid-Ohio School and/or in Events (collectively "**Vehicles**"), Releasees are in no way responsible for and shall have no liability in connection with damages and/or Claims arising out of: (i) Participant's use of the Vehicles, Participant Vehicles and/or Third Party Vehicles; and/or (ii) other person's use of the Vehicles, Participant Vehicle, and/or Third Party Vehicles. If this occurs, no refund of enrollment fees paid will be issued to the Participant and/or Parent/Guardian.

Participant and Parent/Guardian, jointly and severally, agree to assume full responsibility for all damages to any property belonging to GSMO and The Mid-Ohio School (Vehicles provided by GSMO or The Mid-Ohio School are addressed in Paragraph 3), cause by Participant's and/or Parent/Guardian's negligence or misconduct while acting outside the scope of permitted, supervised training activities at The Mid-Ohio School, (as determined by GSMO and The Mid-Ohio School in their sole discretion) and Participant and Parent/Guardian authorize GSMO to bill and collect from Participant and Parent/Guardian (jointly and severally) for these damages (including, but not limited to, the right to bill any credit card provided by Participant and/or Parent/Guardian and to collect costs and attorney fees if these damages are not paid promptly upon demand).
8. Participant and Parent/Guardian acknowledge that the coaches and instructors associated with The Mid-Ohio School (although they are Releasees) are not employees of GSMO, but independent contractors and, therefore, have no authority to amend the terms of the Release or this Exhibit A or to otherwise contractually bind GSMO. Any and all amendments must be in writing and signed by the President of GSMO.
9. In the event the Participant and/or Parent/Guardian sustains any injury while in a Restricted Area and/or during an Event, any and all medical and rescue personnel treating the Participant and/or Parent/Guardian for such injury are hereby authorized to release to GSMO and its sanctioning organizations and insurance carriers any and all medical records of Participant and Parent/Guardian relating to such injury and treatment. Participant and Parent/Guardian agree that this authorization is irrevocable, and Participant and Parent/Guardian agree to execute and deliver to GSMO and Participant's and/or Parent/Guardian's medical and rescue personnel all such other documents and releases necessary to permit the release of these medical records as set forth in this paragraph.
10. This Exhibit A is attached to and incorporated by reference into the Mid-Ohio School Minor and Parent/Guardian Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement executed by Participant and Parent/Guardian. Unless otherwise defined herein the capitalized terms in this Exhibit A shall be the meanings assigned to them in the Release.
11. REGARDLESS OF ANY LANGUAGE IN ANY OTHER ORAL AND/OR WRITTEN STATEMENTS, PARTICIPANT, PARENT/GUARDIAN, AND THE OTHER RELEASORS ACKNOWLEDGE AN AGREE THAT THERE ARE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER WARRANTIES EXPRESS OR IMPLIED, APPLICABLE TO ANY VEHICLE, PARTICIPANT VEHICLE, THIRD PARTY VEHICLE, PARTS, EQUIPMENT, ACCESSORIES, INSTRUMENTS, COMPONENTS, OR OTHER PRODUCTS OR GOODS USED IN ANY MANNER WHATEVER IN OR RELATED TO THEEVENT, VEHICLES, PARTICIPANT VEHICLE, THIRD PARTY VEHICLE, AND/OR THE MID-OHIO SCHOOL REGARDLESS OF THE SOURCE OF SUCH GOODS AND HEREBY WAIVE ALL REMEDIES, WARRANTIES, GUARANTEES OR LIABILITIES, EXPRESSED OR IMPLIED, ARISING BY LAW OR OTHERWISE, INCLUDING ALL CONSEQUENTIAL DAMAGES, EXEMPLARY AND PUNITIVE DAMAGES, WHETHER OR NOT OCCASIONED BY THE NEGLIGENCE OF THE RELEASEES, SUPPLIER OF SUCH GOODS, OR ANY OTHER REASON, ON ACCOUNT OF DEATH OR INJURY TO PERSON OR PROPERTY OR PROPERTY CAUSED BY OR RESULTING FROM THE MANUFACTURE, CONSTRUCTION, DESIGN, FORMULA, DEVELOPMENT OF STANDARDS, PREPARATION, PROCESSING ASSEMBLY, INSPECTION, TESTING, LISTING, CERTIFYING, WARNING, INSTRUCTING, MARKETING, ADVERTISING, REPAIRING, PACKAGING OR LABELING OF ANY SUCH VEHICLE OR PARTICIPANT VEHICLE OR THIRD PARTY VEHICLE, OR PRODUCT OR COMPONENT OF A VEHICLE, PARTICIPANT VEHICLE, THIRD PARTY VEHICLE, OR PRODUCT.

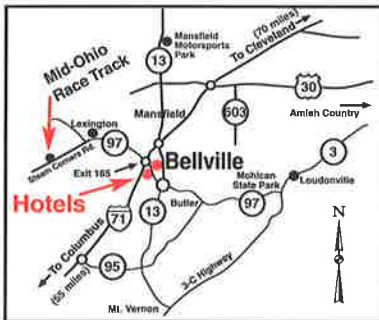

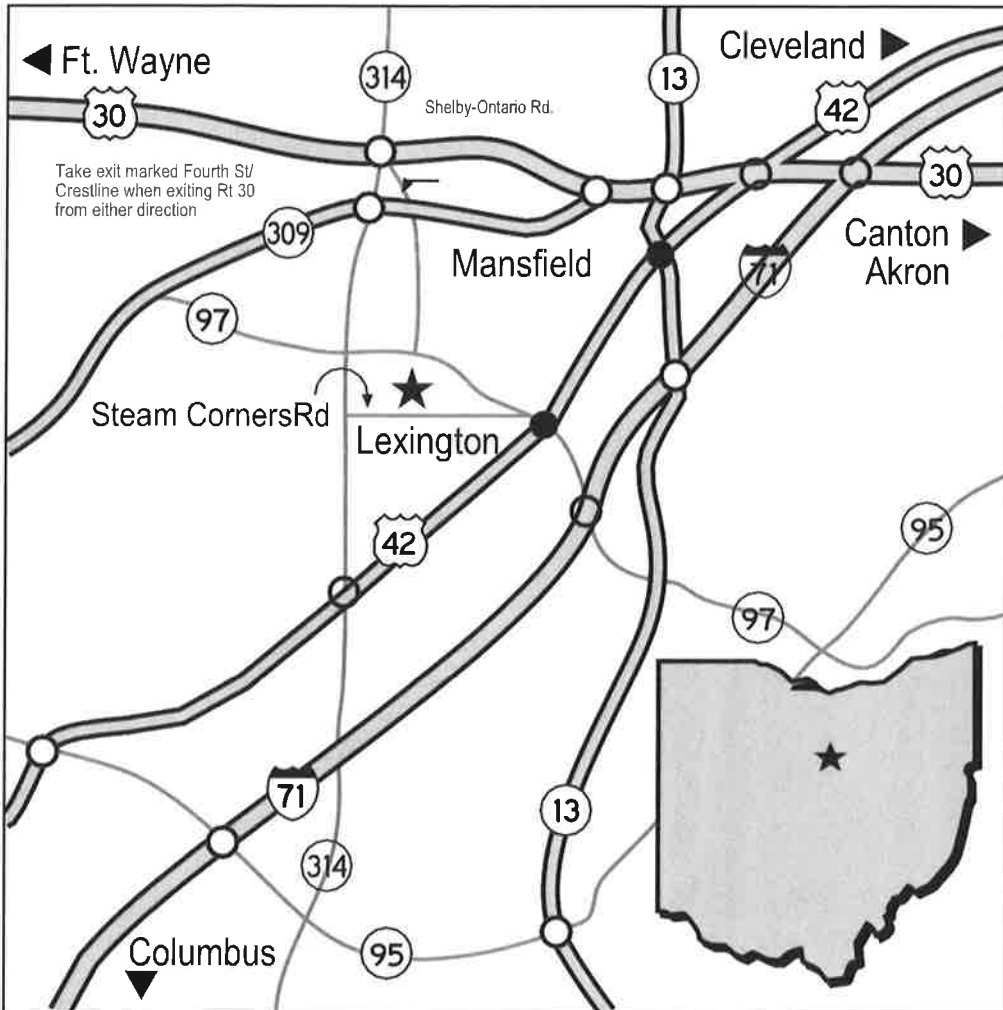

FROM AKRON/CANTON, OHIO

Take U.S. 30 west to Fourth St./Crestline exit. Turn left at end of exit ramp and proceed to stoplight. At stoplight, turn right and then veer right onto St. Rt. 314. Go approximately 7 miles and turn left on Steam Corners Rd. Mid-Ohio is one mile on the left.

Approx. travel time: 1 hour, 10 minutes.

FROM CLEVELAND, OHIO

Take I-71 south to U.S. 30. Go west on U.S. 30 to Fourth St./Crestline exit. Turn left at end of exit ramp and proceed to stoplight. At stoplight, turn right and then veer right onto St. Rt. 314. Go approximately 7 miles and turn left on Steam Corners Rd. Mid-Ohio is one mile on the left.

Approx. travel time: 1 hour, 20 minutes.

FROM COLUMBUS, OHIO

Take I-71 north to St. Rt. 95 east. Follow St. Rt. 95 for 2 miles and go north on St. Rt. 314 for 15 miles. Turn right on Steam Corners Rd. Mid-Ohio is one mile on the left.

Approx. travel time: 1 hour.

FROM FORT WAYNE, INDIANA

Take U.S. 30 east to Fourth St./Crestline exit. Turn right at end of exit ramp and proceed to stoplight. At stoplight, turn right and then veer right onto St. Rt. 314. Go approximately 7 miles and turn left on Steam Corners Rd. Mid-Ohio is one mile on the left.

Approx. travel time: 3 hours.

FROM DETROIT/TOLEDO

Take I-75 south to Route 15 east (Exit #156). Route 15 becomes Route 23 south. Route 30 then joins Route 23. Stay on Route 30 east to Fourth St./Crestline exit. Turn right at end of exit ramp and proceed to stoplight. At stoplight, turn right and then veer right onto St. Rt. 314. Go approximately 7 miles and turn left on Steam Corners Rd. Mid-Ohio is one mile on the left.

Approx. travel time: 2-1/2 to 3 hours.
